Time and history brought these two totally different men (Adams the New Englander, federalist and advocate, and Jefferson the Virginian, classic Republican and writer) together to help create some the fundamental liberties we enjoy today. They were not perfect men, but their legal and political legacies can be seen every day in courtrooms across the country. Their timeless words echo through the generations, and as a nation we continue to try to live up to the ideals they espoused. Historian Joseph Ellis wrote that they “came to embody the American dialogue.”
